- 02. Should prove his identity when obtaining procurement applications.
- 03. Application will only be issued after payment of the Bid Form Fee and the Deposit Amount.
- 04. Bidder should submit quotations in agreement with the conditions issued with the applications.
- 05. Successful bidder on intimation, should deposit in addition to the deposit amount, an amount equal to a 03 months rental and 50% of the Tender Amount when signing the Agreement. The balance 50% should be paid on the fifth month during the first period.
- 06. Every leasehold given will be legally valid for a period of one year from the commencing date.
- 07. Except for the Bid Security Deposit, all other payments will be subject to Government approved taxes.
- 08. The quotation amounts should be clearly and accurately stated in the applications. Any alterations made later on should be deleted in a single stroke and place the signature. The altered amounts should also be written in clear letters and digits. Applications submitted contrary to it will be rejected.
- 09. Quotations, made on procurement form issued by the Sabha should be completed properly in two copies as the original and duplicate in separate covers and then both covers be placed in a single sealed cover marked the name of the leasehold and "Municipal Commissioner, Municipal Council, Negombo" at the left side top corner, could either be sent by registered post or placed in the Tender Box kept in the office of the Municipal Commissioner to be received at or before 10.00 a.m. on 07.11.2025.
